

First District Board of Control
Service Agreement

This Service Agreement is entered into this 25th day of MAY, 2017 between the First District Board of Control (Board) and the North Idaho Officials' Association, Inc. (NIOA). The terms of this Service Agreement shall terminate on June 30, 2019.

The NIOA hereby asserts that it is an independent contractor organized to train, test, evaluate and supervise the performance of officials in Idaho High School Activities Association (IHSAA) District 1. The Board represents that it is the organization empowered and delegated the responsibility of overseeing high school extracurricular and co-curricular activities. Therefore, in consideration for the Board entering into this service agreement for the officiating of all high school sports contests within the bounds of the First District, the NIOA agrees to the following terms of performance:

- A) The NIOA will monitor the training planned and presented by each sport' Evaluation Committee. All responsibilities for recruiting, training and organizing/presenting local clinics for officials will rest solely with the NIOA Evaluation Committee. If the Evaluation Committee fails to perform their responsibilities, the NIOA asserts it will assign this training obligation to another official or group of officials.
- B) The NIOA assures it will take seriously any performance complaints against officials from school administrations, coaches or fellow officials. It may conduct a timely investigation of all pertinent facts from all available sources and provide disciplinary rulings in a timely manner. Initial discipline of officials will be handled by the Commissioner and the NIOA Executive Board (E-Board), in accordance with the NIOA by-laws. The NIOA will provide a copy of the discipline policy to the Board. Commissioners and the Board may ask or be asked to assist in resolving specific situations.
- C) Only Idaho State registered officials in good standing, who have completed all of the requirements outlined by IHSAA to be certified officials may be assigned to officiate contests with the First District. A \$10.00 clinic fee will be charged to officials who choose not to pay NIOA clinic fees at the state clinic for their sport. Sports Commissioners, who serve at the will of the Board, shall not assign anyone not properly certified as an Idaho State registered official to work contests with the First District. Each Evaluation Committee shall provide the Commissioner with a list of qualified officials in a timely manner so contest assignments can be made.
- D) A member of the Evaluation Committee when possible shall review the master schedule with the commission of his/her respective sport prior to its disbursement to ensure rotation and fair placement of officials.

I. SERVICE COMPENSATION

The parties agree the independent contractors providing officiating services shall be compensated for all contests according to the Salary Contract. All schools within a classification may elect to use AriborPay as a method of payment. When utilizing AriborPay as method of payment, the funds must be transferred to AriborPay and finalized within 2-3 business days. The details of the program will be made known to all parties involved prior

to the commencement of this payment option. Otherwise, payment is to be made prior to the contest, in situations where payment is not possible at the time of the contest, due to name changes, weather, and/or cancellations, etc. the unpaid officials shall complete an information/payment voucher provided by the school. Thereafter said vouchers are returned to the custody of the school officials and payment to officials via US Mail shall occur to the onset of the following week activities. Every attempt will be made to Board of Control for possible action and/or fines.

II. SELECTION OF OFFICIALS FOR DISTRICT AND STATE TOURNAMENT

The parties agree that for the selection of officials for tournament contests both officials and coaches shall share responsibility in the selection process for all sports. The Secretary of the Board of Control shall compile a list of qualified registered officials who are eligible to work district and state tournaments. The Secretary of the Board of Control shall provide this list to the coaches who shall rank the officials. The officials shall compile their list in rank order using a process overseen by their sport's evaluation committee. The sport's commissioner will also compile a list ranking each of the officials based on observation and game evaluations. Thereafter, each list is combined, giving each party 40/40/20 percent representation in the process. In the event the sport's commissioner is an active member of the official's group, each party, NIOA and coaches, would retain 50/50 representation in the process. An active member would be defined as someone having their name on the list of officials considered. Each sport may choose by vote whether to use the 40/40/20 system or the 50/50 system if the sport commissioner is an active member.

The pooling of the two lists for all classifications shall occur in the following manner:

- a. All awarded points, if used in the process shall be eliminated, and a numerical ranking from first, second, third, etc. will be used
- b. The Secretary of the Board of Control and a representative of the NIOA Evaluation committee for said sport shall compile the list of officials. In the case of having a working commissioner, said commissioner shall submit his/her commissioner (20%) vote prior to receiving coaches and NIOA peer votes.
- c. Once the ranked officials list is compiled by the Secretary of the Board of Control and the E-Board representative, it shall be provided to the Commissioner who shall make the district contest assignments and provide to the IHSSA the list of officials who have been selected to officiate state tournaments.

Once the Commissioners have combined list compiled as specified above, they shall make contest assignments in the following manner.

1. For football, since there are no district games, the Commissioner shall select highest ranked officials qualified by position to officiate state contests.
2. Sports other than football schedule both district and state tournament contests. For state tournament contests, commissioners shall select officials from the combined list in order in which they are ranked.
3. Individual sports may use systems that ensure rotations of officials chosen for state tournaments. Commissioners must have majority approval of all officials to initiate or continue a rotation process.
4. It is further agreed that the Commissioner shall work closely with the NIOA to ensure that the above steps are followed to the satisfaction of all parties to this agreement.

Copies of the individual lists, combined lists, and all District/State game assignments shall be made available to both the NIOA and Secretary of the Board of Control for review and archive retention.

III. CLARIFICATION OF COMMISSIONERS DUTIES

The Parties of the Service Agreement do hereby agree that the Commissioners selected and paid by the Board are not empowered to act in any fashion as a representative for the NIOA. In addition, they have no duties or responsibilities for the conduct of business within the Association unless they happen to be members. Disciplining of officials will be a joint responsibility of the Sport's Commissioner, NIOA Executive Committee and the Board. The parties of this agreement further stipulate that the duties, responsibilities, and instructions given to each Commissioner shall not conflict with this agreement. It is further agreed that each party shall receive a copy of this Service Agreement.

- Coaches shall rate/evaluate officials on Arbiter so the Commissioner can view as per Board directives. A summarized version of coach's evaluations shall be made available to the Evaluation Committee upon request.
- Assignments will be put on Arbiter for Officials and Schools to view at least one week prior to the first contest listed on that schedule. Officials will be given two weeks prior notice for tournaments if at all possible.
- Commissioners shall schedule time at the State Rules Clinic for NIOA information and Evaluation Committee designation.
- Each official shall receive a District Pass allowing each official and 1 guest entry to any high school sports contest during the school year.


IV. TERMS AND CONDITIONS

This agreement contains all the terms and conditions agreed to by the Parties. Only those terms in writing, expressing consideration and signed by the Parties are enforceable, no other terms or oral promises not contained in the written Agreement may be legally enforced.

V. LEGAL EFFECT

This agreement shall take effect upon signing, and will continue un-interrupted Unless either party in writing desire to void or amend said contract. Fee Compensation portions of this agreement as detailed in Paragraph I. Any portion of The contract may be amended by mutual agreement.



1. \$5.00 per contest shall be added to regular season fees for all district contests in all sports except Wrestling, which will be compensated by an additional \$0.25 per match over regular season varsity tournaments fees.
2. Cancellations shall be paid in the following manner: 1) notification provided to an official(s) by the school or sports commissioner prior to leaving for a contest results in no fees; 2) if notification is not provided as stated above, or cancellation occurs after the officials arrive, but prior to the start of the contest, official(s) receive mileage and a \$25.00 fee; 3) if cancellation occurs following the start of a game, but before sufficient innings or time are played to constitute an official contest, officials shall be paid for mileage and the full contest fee; 4) officials completing a rescheduled suspended contest shall receive ½ game fee if they are completing a game which continues from the 5th inning on, if they are completing a game which continues in less than the 5th inning (1st – 4th), the officials shall receive a full game fee.
3. If one school's Varsity team has a contest against a Sub-Varsity team from another school, Officials will receive fees for a Varsity level contest.
4. All Officials may receive their payment thru Arbiter in Refpay and can be direct deposited to their checking account, savings account or on a card issued thru Arbiter. This is at no cost to the Official unless requested by the Official to have check or deposit sent to them for each match/game, then there is a fee to be determined by Arbiter.
5. NIOA agrees to provide officials as available for YEA Fundraising Jamborees at no cost. All Jamborees must be scheduled with the sport Commissioner to assure adequate coverage by officials.

MILEAGE: (ALL SPORTS – ONE OFFICIAL PER GAME)

Up to 100 Miles round trip	37.00
101 to 150 Miles round trip	42.00
Over 150 Miles round trip	47.00

FIRST CAR MILAGE is given to the driver traveling the farthest.


SECOND DRIVER: (if needed) – Thirty-five cents per mile up to a maximum of \$25.00 round trip.

NO mileage will be paid to officials within their school districts if the round trip is less than twenty-five (25) miles.

“Mileage rates will be reviewed annually at the first Board of Control meeting each school year. The board will evaluate any NIOA justification of need in order to adjust mileage from the current rate.”

The terms of this agreement shall expire June 30, 2019.


